ORDINANCE NO 48

ORONOKO TOWNSIDP GROUP INSURANCE COVERAGE

An ordinance to create and establish a township group insurance plan covering life, health. hospitalization, medical and surgical service and expense and accident insurance for certain classes of township officers and employees and their dependents and to authorize the township supervisor and the township clerk to contract, in the name of the township, for such plan: to define those classes of officers and employees who shall be covered by such group insurance plan; to set forth the respective per centum shares which Oronoko Township and the officers and employees shall contribute to the premium or charges arising under such group insurance plan and further provide for the deduction of contributions from officers' and employees' compensation; to provide a method for noncoverage of an officer or employee of any group insurance plan in existence on the effective date of this ordinance; and to repeal all ordinances or parts of ordinances in conflict herewith.

SECTION 1

This ordinance shall be known and cited as the Oronoko Township Group Insurance Plan Ordinance.

SECTION 2.

Pursuant to Public Act 77 of 1989, the Township of Oronoko hereby creates and establishes group insurance plan covering life, health, hospitalization, medical and surgical service and expense and accident insurance of its officers and employees enumerated herein. and their dependents, and for such purposes, also hereby authorized the township supervisor and the township clerk to contract, in the name of the township board, subject to approval of the township board, with any company authorized to transact such business within the State of Michigan for such group insurance policies.

SECTION 3

The group insurance plans, both life and health, created, established and contracted for under this ordinance shall cover each person within the following classes of elected officials and employees and shall also cover the dependents of such eligible persons:

- 0) HEALTH INSURANCE: All full time township employees who are employed by the Township more than thirty (30) hours per week on a regular basis.
- (2) LIFE INSURANCE All elected officials and all full time township employees who are employed by the Township more than thirty-five (35) hours per week on a regular basis.

SECTION 4.

The Township of Oronoko shall annually contribute one hundred (100%) per centum of the portion of the premium or charges arising under such life insurance contract for each person within the class of persons enumerated in Section 3 hereof. Additionally, the Township of Oronoko shall annually contribute one hundred 000%) per centum of that portion of the premium or charges under such health, hospitalization, medical and surgical service and expense and accident insurance contract for each person within the class of person or enumerated in Section 3 hereof. Such township contribution shall be secured from the general fund of the township. Each person within such class shall be responsible for the remainder of the premium or charges not paid for by the township and the township treasurer is hereby authorized to deduct the same from each person's pay, salary, or compensation, and to apply to such person's responsibility. Any person desiring not to be so covered shall give written notice to the Township Clerk that he desires not to be insured or covered, and if the notice is received before the person has become insured or covered under the contract, he shall not be covered thereunder. If the notice is received after the individual has become insured or covered, his coverage under the contract shall cease as provided for in the contract.

SECTION 5

The Township of Oronoko hereby ratifies and confirms the validity of any life, health, hospitalization, medical and surgical services and expense and accident insurance or anyone of more of such forms of insurance in existence on the effective date of this ordinance.

SECTION 6

This ordinance shall take effect on the date of its publication. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

This Ordinance shall take immediate effect on the date of publication of the notice of the enactment of the Ordinance.
